



General Information and Instructions to the Candidates

- ii) Interested candidates having requisite qualification and experience may appear for registration and walk-in-interview to be conducted on dated **18.09.2024** from **11.00 AM to 2.00 P.M** in the Conference Hall of Directorate of AYUSH, Odisha. In case, the said interview could not be conducted as per scheduled date and time, the candidates are requested to visit the website of Directorate of AYUSH, Odisha at regular intervals for any notification, updates etc. for the said walk-in-interview.
- iii) Candidates fulfilling all the criteria are required to come for interview with duly filled in application in prescribed format and bring all certificates /Mark sheets/ Testimonials (Research degree, teaching experience, Ph.D. guidance and Research publication etc.) in original and a set of self-attested photocopies of the same, in support of age, qualification and experience etc. for verification.
- iv) Candidates not fulfilling the eligibility criteria and other requirement will not be entertained.
- v) Incomplete application in any form will be summarily rejected.
- vi) The person engaged on contractual basis shall have to execute an agreement with the Director AYUSH, Odisha, Bhubaneswar as communicated vide Health & F.W. Department, Odisha letter No. AYUR-M-52/2014-12707/H dated 04.06.2015.
- vii) The persons engaged on contractual basis will have no right for any permanent/ temporary employment under any Govt. AYUSH institution of the State.
- viii) The period of experience rendered by candidate on part-time basis, daily wages, visiting/guest faculty will not count while calculating valid experience.
